### ASSIGNMENT

Two days (16 hours) of surveillance was approved and assigned for claimant xxxxx xxxxxxxx in October - 2012.

The assignment was to effort obtaining videotape of the claimant utilizing any activity with a reported right shoulder injury. The claimant, a counter worker, alleges he was unloading a truck (not his regular job) and has had 2 surgeries on his right shoulder since the incident.

The clearly stated goal is to determine if the claimant is performing any vigorous activity and/or determine if the claimant continues to work elsewhere despite his allegation that he is unable and/or determine his functional capacity.



- cleaning the vinyl siding, soffit's and windows of his residence and garage with a brush on a pole (extended up to 6' long) using both hands, often while standing on a ladder and/or while on the ground with quick and easy motions at all times
- bending over with ease and using an air gun with his right hand for an extended period to blow leaves off of the roof of his house, while walking on top of and along the roof of the house
- flipping a hose to move it with each hand individually with ease
- carrying a 5-foot wooden ladder with two hands at shoulder level out in front of him with ease as he walked with a normal gait and pace
- carrying a 5-foot wooden ladder in his right hand at hip level with ease as he walked with a normal gait and pace
- using a 3-4 foot long 2 x 4 over his head while on a ladder to knock some things off the siding of the garage with a series of quick and easy motions












## ***SURVEILLANCE SUMMARIES AND RESULTS:***

**Tuesday, 10-23-12**      **(4:45 p.m. - 7:00 p.m.)**      **2.75 hours**      &

**Wednesday, 10-23-12**      **(7:00 a.m. - 5:00 p.m.)**      **10.0 hours**

Surveillance was performed by Gateway Investigations on claimant xxxxxxxxxx on Tuesday, October 23, 2012 from 4:45 p.m. – 7:00 p.m. for a total of 2.75 hours (billing for 2.0) and on Wednesday, October 24, 2012 from 7:00 a.m. – 5:00 p.m. for a total 10.0 hours.

We have now completed 12.0 of the 16.0 hours scheduled for this assignment.

Note: this claimant had an alleged right shoulder injury in December - 2010 and has had two right shoulder surgeries.

On this day, we captured about 80 total minutes of video showing the claimant engaged in the following activities:

- cleaning the vinyl siding, soffit's and windows of his residence and garage with a brush on a pole (extended up to 6' long) using both hands, often while standing on a ladder and/or while on the ground with quick and easy motions at all times
- bending over with ease and using an air gun with his right hand for an extended period to blow leaves off of the roof of his house, while walking on top of and along the roof of the house
- flipping a hose to move it with each hand individually with ease
- carrying a 5-foot wooden ladder with two hands at shoulder level out in front of him with ease as he walked with a normal gait and pace
- carrying a 5-foot wooden ladder in his right hand at hip level with ease as he walked with a normal gait and pace
- using a 3-4 foot long 2 x 4 over his head while on a ladder to knock some things off the siding of the garage with a series of quick and easy motions

The operative arrived at the claimant's provided address of xxxxxxxxxxxxxxxxxxxxxxxxxxxxxxxx on Tuesday the 23rd at 4:45 p.m.

Upon arrival, the operative noted a car in front of the residence with a younger male inside. The operative obtained a surveillance position in a cul-de-sac in front of an apartment building and across from the claimant's residence.

A few moments later, a young male walked from the back of the residence, got in the car and it pulled away. The residence is best described as a (light yellow) vinyl sided residence with a detached, 2-car garage in the rear with a front drive. The front blinds were open as were some rear blinds, allowing the operative to see through the residence.

A few minutes later, the operative noted a person inside the residence closely matching the claimants provided photo and description. This person appeared to be mopping the floor. A few minutes later, the person was observed walking back and forth.

At 6:04 p.m., a Dodge Durango pulled into the driveway and a woman (about 30 yrs old) went in the front door. She departed at 6:11 p.m.

A short time later, with darkness approaching, the lights came on inside and the person believed to be the claimant was observed walking around and talking on a phone.

At 7:10 p.m., the operative suspended surveillance due to darkness.

---

The operative arrived back at the residence the following morning and noted that all of the windows were closed and there were no cars parked at the residence.

At 8:50 a.m., the front blinds were open and a man was observed walking around inside.

At 9:02 a.m., a male closely matching the claimant's photo and description (h/a "claimant") was captured walking out to the garage which had just opened.

A few minutes later, the claimant was captured raking up some leaves in the driveway with a series of quick and easy motions.

The claimant had his left hand below the right hand on the rake during the usage.

After raking a few different areas, the claimant retrieved a paper lawn bag from the garage, opened it at the top and gave it a quick snap with the left hand to "blow" open the bag.

The claimant then used both hands to scoop up the debris and put it in the bag with ease. The claimant then walked into a backyard area out of view.

At 9:37 a.m., the claimant was captured pulling a yellow air hose out of the garage with ease. The operative had been hearing an air compressor running prior to this activity.

The claimant used both hands to pull on the hose, leading with his left hand. The claimant then went into the backyard with the hose and was observed lifting it up over a privacy fence with ease.

At 9:48 a.m., the claimant was captured walking on the roof and using an air hose to blow leaves off the roof.

The claimant leaned over, sometimes while walking, and held his right arm down and blew leaves off the side of the roof until 9:56 a.m.

The claimant then sat down near the edge of the roof and began cleaning out the gutters with both hands and tossing the debris forward off the roof with a series of fluid and easy motions.

The claimant then "crab walked" on both hands and his feet (with his butt slightly off the ground) to move a few feet to his left. The claimant would then clean more of the gutter in a similar fashion.

The claimant moved positions about 7 different times and usually took 2 "steps" at a time. The claimant then turned over to his right and used his right hand to get up into a standing position.

The claimant then walked over, picked up the air hose with his left hand and began winding it up with both hands as he walked toward the back of the roof and out of view at 10:01 a.m.

At 10:05 a.m., the claimant was captured walking across the roof of the detached garage and out of view. At 10:10 a.m., the claimant walked across to the other side of the roof of the garage and out of view.

At 10:15 a.m., the claimant walked into the garage, came back out of the garage and lifted the air hose off of the fence with both hands at around head level with ease.

Over the next 20 minutes, the claimant was occasionally captured walking in and out of the garage, doing a little raking

and winding back up the air hose.

At 10:42 a.m., the claimant was captured walking out into the front of the driveway and he began raking once again. The claimant then began raking along the front of the bushes, lining the front of the house and the bushes themselves.

The claimant then raked around a landscaped area and around a front tree. At 10:47 a.m., the claimant walked into the garage and out of view.

During this time of raking, the claimant had his left hand lower on the rake and used a fluid sweeping motion, sometimes having to raise his right hand to head level with ease.

Between 11:02 a.m. and 11:48 a.m., the claimant was captured walking back and forth between the garage and the backyard on many occasions.

Around 11:44 a.m., the operative could hear an air powered die grinder for about 1 minute while the claimant was out of view.

At 11:50 a.m., the claimant went into the house and was captured closing a screen on the front storm door and closing the front door.

A couple times, around 12:45 p.m., the claimant was captured walking in the backyard through the open front and rear windows.

At 12:56 p.m., the claimant was captured using a brush on a pole that had a water hose attached, as he was wiping down the rear window and around the window with a series of quick and easy motions.

At 1:18 p.m., the claimant was captured pulling a hose out into the driveway. The claimant was then captured pulling a 5-foot wooden ladder towards him with his right hand.

The claimant then “whipped” the hose with his right hand to get it to move over (as it was likely caught over something). The claimants hand went up to his neck level on one whip, up to his shoulder level on another whip and multiple other “smaller” motioned whips.

The claimant then pulled the hose out into the front end of the driveway by the pole the brush was on with ease. The claimant started pulling with just the right hand and then put the left hand on the hose and pulled as he walked with both hands on the hose near his hip, with his elbows pointing slightly backwards.

The claimant then leaned the pole against the residence and walked to the back yard.

At 1:25 p.m., the claimant was captured walking out to a front corner of the residence and began pushing on some corner molding with both hands above his head.

The claimant then picked up the pole and did a little brushing on the siding before setting the pole down and going toward the 5-foot wooden ladder. He then carried it with both hands at shoulder level over to the house.

The claimant then carried a 5 gallon bucket of water with his left hand to near the ladder. The claimant then got up on the ladder and wiped the area near the peak of the roof with a fluid and easy motion.

The claimant held his left hand higher on the pole, but occasionally raised his right hand above his head while brushing the siding. The claimant would occasionally use just his right hand to dip the brush into the bucket on the ground with a fluid

and easy motion. The claimant then continued brushing for about 10 consecutive minutes before finally getting down off the ladder.

The claimant then pulled the ladder with both hands toward the front of the house and then brought a bucket of water over with his left hand. The claimant then got up on the ladder, realized the hose was now under the ladder and began trying to rock the ladder back by holding onto the top of the ladder with his right hand and pulling back while trying to whip the hose out with his left hand. (All while still standing on the ladder --- we note the impressive agility and strength required to do this.)

The claimant then got back up on the ladder and wiped on the siding for 3-4 more minutes.

At 1:43 p.m., the claimant got down and carried the open ladder with both hands at stomach level towards the back of the house and put it down with ease. The claimant then carried the bucket in his left hand and the pole in his right hand back towards the ladder.

The claimant then brushed the siding for about 5 minutes while standing on the ground. The claimant then got up on the ladder and brushed on that area of the siding for 3-4 minutes.

The claimant then got down, closed the ladder and carried it in his right hand at hip level to the backyard and out of view. The claimant then brushed on the side of the house while standing on the ground for another few minutes before walking out of view into the backyard.

At 2:14 p.m., the claimant began pulling the hose out to the far side of the front of the house. The claimant pulled on the hose with his left hand while holding the pole out with his right hand with ease.

He then laid down the pole and pulled with both hands before picking the pole up with only his right hand and he pulled the hose with just his left hand again as well.

The claimant then carried over a bucket of water with his left hand and began brushing on the front of the residence at 2:19 p.m. The claimant scrubbed on the front of the residence almost nonstop until 2:47 p.m.

The claimant brushed high, low, at chest level and in an upward, downward and sideways motion with a series of quick and easy movements.

The claimant occasionally moved the bucket with his left hand and pulled on the hose with his left or with both hands. The claimant led with his left hand while brushing.

At 2:48 p.m., the claimant carried the bucket of water back towards the rear garage and out of view.

At 3:06 p.m., the claimant was captured for a few minutes brushing on the vinyl above the garage while he was walking. A few moments later, the claimant carried the ladder toward the front of the garage. He then got up on the ladder, scrubbed for about a minute at the highest points and then got down and moved the ladder to the left with both hands. Once again, he got up on the ladder and brushed that area. A few moments later, the claimant was captured scrubbing on the vinyl and, a few minutes later, the claimant was brushing on the other side of the garage.

At 3:20 p.m., the claimant moved the ladder back to the front of the garage with both hands. He got up on the ladder and began using a 3-4 foot 2 x 4 with both hands over his head to knock a few things off of the siding with a hammering motion along a few different areas of the vinyl.

The claimant then got down and walked around, eventually carrying the ladder out of view with his left hand.

At 3:25 p.m., the claimant was captured brushing on the garage for about 6 minutes before getting down. He carried the bucket with his left hand out of view and then walked over, closed a privacy gate and went inside. The claimant could occasionally be observed walking around inside the residence.

At 5:00 p.m., with no further outdoor activity, surveillance was suspended and scheduled to resume the following morning.

Surveillance is scheduled to resume on Thursday, October 25, 2012.

**Thursday, 10-25-12**                      **(6:00 a.m. - 3:00 p.m.)**                      **9.0 hours**

Surveillance was performed by Gateway Investigations on claimant xxxxxxxxxxxxxxxxxxxx on Thursday, October 25, 2012 from 8:00 a.m. – 1:00 p.m. for a total 5.0 hours.

We have now completed 17.0 of the 16.0 hours scheduled for this assignment.

Note: this claimant had a right shoulder injury in December 2010 and has had two right shoulder surgeries.

On this day, we captured about 27 total minutes of video showing the claimant engaged in the following activities:

- working to fix the gate of his privacy fence leading to the back yard
- using a cordless drill with his right hand
- using a hammer with right hand
- pulling on and pushing on a wooden gate with both hands
- pulling a gate closed with his right arm extended outward and behind him
- pulling a gate open with his right hand on top of the 6-foot tall gate
- driving a vehicle and steering with both hands with ease
- holding a door open with his right arm extended behind him for another person at a courthouse

The operative arrived at the claimant's provided address of xxxxxxxx at 8:00 a.m. Upon arrival, the operative noted that all of the window blinds were closed. The operative thus obtained a surveillance position across the cul-de-sac with a clear view of the residence.

The weather on this day was partly cloudy with a high in the upper 70's.

At 8:20 a.m., the window blinds opened and a couple people could be observed walking around inside.

At 8:47 a.m., the claimant's son came out of the rear gate as the garage door opened. A moment later, the claimant was captured coming out through the gate and closing the gate with his left hand. He was holding a water bottle in his right hand and walked with a normal gait and pace into the garage.

A moment later, an (eggplant) Plymouth Grand Voyager bearing Illinois tag # xxx xxxx was captured backing out of the driveway with the claimant driving. This vehicle was found to be registered to the claimant in a pre-surveillance check.

The claimant then drove about 6-7 miles to the xxxxxxxx Courthouse.

At 9:05 a.m., the claimant was captured walking toward the front door. He put out a cigarette in an ashtray by the front door. A few moments later, the claimant was captured walking down a hall, following his son through a door.

The claimant then held the door open with an extended right arm behind him at shoulder level with ease to allow for a

woman to pass through who was walking in the opposite direction.

The claimant then walked through another door, holding it open with his right hand at head level with ease as he passed through. The claimant then stood with his son while they looked at a traffic court docket (the claimant's son was holding a ticket in his hand). The claimant also hiked up the back of his pants with both hands with ease during this time.

A few moments later, after apparently not finding his name on the docket, the claimant and his son were captured at a cashier's counter. The operative then elected to return to the surveillance vehicle.

At 9:17 a.m., the claimant was captured walking back out to his van. The claimant unlocked the door with his right, opened the door with his left and entered with a fluid and easy motion. The claimant lit up a cigarette and then pulled away using both hands to turn the steering wheel.

At 9:37 a.m., the claimant was captured walking from the garage, opening and closing the privacy fence gate with his left hand to check it out and then went into the backyard and out of view.

At 10:09 a.m., the claimant was captured pushing open the gate with his left hand and he latched it open with his right. The claimant then walked to the garage and returned a few minutes later with a cordless drill in his right hand.

The claimant turned around, went back into the garage, came back out of the garage and went into the backyard with the drill still in his right hand.

At 10:13 a.m., the claimant walked to the garage and returned to the backyard with a small board in his hand.

At 10:15 a.m., the claimant walked from the garage to the backyard with a tool in his right hand.

At 10:16 a.m., the claimant was captured using the cordless drill with his right hand on the gate at ankle level while bent over for an extended period. The claimant further gave the drill a couple "twists" while down at this level with his right hand.

The claimant then used the drill at hip level and at shoulder level with his right hand with a series of quick and easy motions. The claimant was clearly pushing hard on the drill with his right arm with his elbow at his side in a bent position.

The claimant then unlatched the gate with his right hand and pulled the gate closed with a right arm extended back behind him at chest level with ease.

The claimant then opened and closed the gate to check its fit before walking to the garage and returning with a hammer. The claimant then walked out of view behind the gate, came back out with a hammer in hand, checked the fit of the gate and then disappeared again. He came back out with a hammer in hand and checked the fit once again.

Over the next 15 minutes the claimant walked to the garage, disappeared into the back yard and checked the fit of the gate on multiple occasions.

The claimant used his right hand to open and close the gate on the handle on almost every occasion.

At 10:38 a.m., the claimant was captured pulling on a hammer that was hooked onto the edge of the gate with his right hand to try and adjust its fit.

The claimant then walked back and forth to the garage and bent over while looking at/working on the gate (he was

mostly out of the operative's view.)

At 10:50 a.m., the claimant was checking the fit of the door and pressed on the top of the gate with his right hand. A moment later, the claimant pulled open the gate with his right hand that was on top of the gate. The claimant and his son then spent a moment looking at the gate. The claimant then used the hammer in his right hand to hit a lower spot of the gate and then walked to the backyard.

At 10:52 a.m., the claimant was captured using a drill with his right hand on the gate at shin level, while preventing the gate from swinging with left hand. He also did this with the drill at knee level and eventually back at shin level. The claimant then stood up and walked to the backyard.

Over the next 15 minutes, the claimant made multiple trips to the garage. He was partially captured working on the back side of the gate and checking the fit of the door.

At 11:05 a.m., the claimant was captured walking to the garage and began using a push broom to sweep up the area near the garage door. The claimant had his left hand low and used the broom to push and pull debris for about 4 minutes. The claimant's son continued to work on the gate.

At 11:09 a.m., the claimant was captured walking out of the garage while carrying a shovel and the claimant walked out of view.

Between 11:10 and 11:45 a.m., the claimant was occasionally captured walking back and forth to the garage, bending over in the area of the gate and checking the fit of the gate.

At 11:46 a.m., the claimant carried the drill in his right hand and had some tools in his left hand as he walked toward the garage.

At 11:49 a.m., the claimant was captured picking up some items off the ground near the gate (possibly screws and/or nails).

At 11:50 a.m., the claimant was captured walking away from the garage as it closed. The claimant closed the gate a couple times with his right hand to check the fit and then went into the backyard.

The claimant and/or his son could then be observed walking inside the residence on occasion.

At 1:00 p.m., with no further outdoor activity noted, surveillance was terminated.

## ***POST-SURVEILLANCE OVERVIEW:***

--- The claimant was active in a walking capacity on both days of surveillance and in a driving capacity during the 2nd day of surveillance. The claimant walked with a normal gait and pace at all times.

--- The claimant exhibited a normal functioning capacity of his right shoulder as evidenced by his ability to:

\* extend his right arm upward and/or fully extended outward with a series of quick and easy motions while

--- raking leaves on multiple occasions

--- vigorously using a push broom for an extended period


--- while sitting on his roof, lunging forward to scoop up leaves out of his gutter and thrust them forward on multiple occasions

--- use a drill with the drill extensively in his right hand, requiring pressure and force for an extended period on multiple occasions

--- swing open and/or sweep shut a gate door with a fluid movement of his right hand/ arm on multiple occasions

--- The claimant exhibited an ability, without hesitation or distress, to bend low and quickly rise to a standing position.

--- We find no evidence of this claimant working at another place of business.
